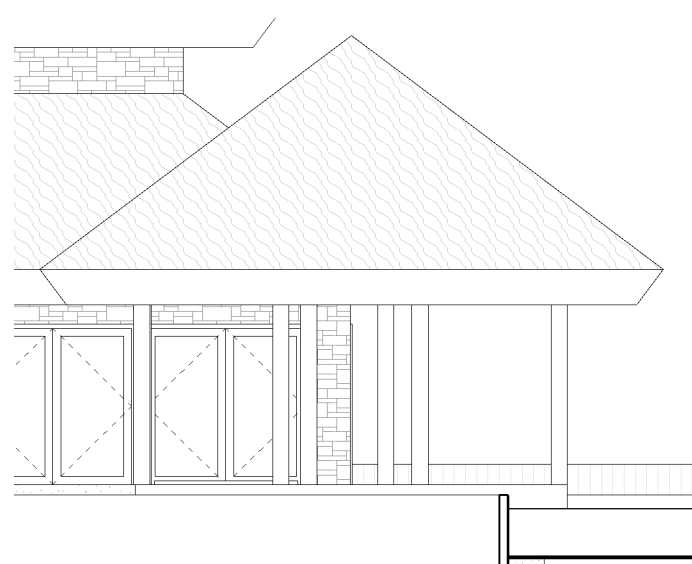
1 GATHERING ELEVATION 2

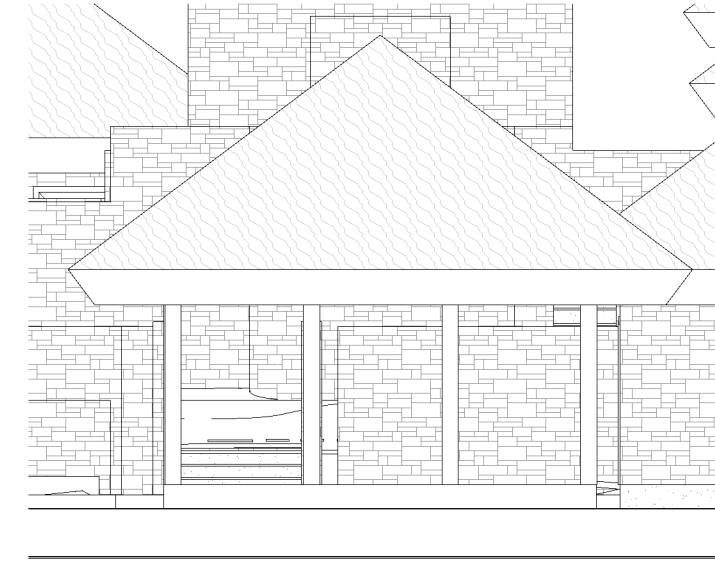
2 GATHERING, KITCHEN
